#### **Key Discussion Topics**

- What is the role of natural gas in achieving a sustainable energy mix?
- In what ways can natural gas contribute to the goals for energy access, affordability and choice; how are infrastructure needs best addressed & what role do multilateral institutions play?
- What market, policy, or technological changes are required for natural gas to contribute effectively to the objective of reducing energy poverty and improving living standards?
- Will natural gas demand be driven by power, transportation, industrial or domestic uses? Role of small scale LNG in expanding the natural gas market?

The scene setter frames the topic considering the perspectives to be shared by speakers.

#### 9:45-10:15: Speaker Presentations

Each speaker will present his/her views for 5 to 7 minutes. A countdown timer will offer warnings at 3 minutes and at 1 minute remaining.

#### 10:15-10:45: Interactive Discussion

The Moderator highlights the main points, and then facilitates a discussion among speakers and participants.

#### 10:45-10:50: Interactive Survey

As this is the first interactive survey of the Ministerial, the Master of Ceremonies, Ms Eithne Treanor will explain to participants how to place their votes, followed by two test questions and results.

Ms Treanor will briefly sum up the views presented in the session and conduct the interactive survey based on the questions provided. She will notify the participants they have 20 seconds to answer the question once the voting is open. She will close the voting and share the results with participants once available.

#### 10:50-10:55: Key Takeaways and Conclusion

The Chair asks the moderator and each speaker to summarise in one sentence his/her key message or what he/she learned from the session. After all speakers have shared their conclusions, the Chair will add his final remarks and will thank all of the participants before closing the session.
