Opening remarks by Aldo Flores-Quiroga Secretary General, International Energy Forum

In the **1930s** Mexico virtually **started the era** of the national oil company, with the founding of Pemex. In the **1970s** discovered one of the last super-giant oilfields -Cantarell. In the introduced a formula to price oil that went on to become the standard for international oilmarket transactions. Recently it has drawn attention for its success in hedging against oil price volatility - one of the most complex challenges of our times.

In every case Mexico's approach has shaped perceptions of what's possible.

It's great this Mexico Energy Day takes place at the IEF – the neutral venue for an open exchange of views on energy policy and the evolution of international energy markets.

Your presence here reaffirms the IEF as **THE** platform for the global energy dialogue.
