## About IEF -The Home of the Global Energy Dialogue

The International Energy Forum (IEF) is the world's largest international energy organisation with 70 Member Countries from both producing and consuming nations. It is truly the global home of energy dialogue.

The Forum's biennial Ministerial Meetings are the world's largest gathering of Energy Ministers.

While the IEF does not make policy, it is a neutral platform with a broad mandate to examine all energy policy and market issues through dialogue with senior government and industry decision makers including oil and gas, clean and renewable energy, sustainability, energy transitions and new technologies, and data transparency as well as providing focus to the critical issue of energy poverty.

Originally founded 30 years ago as a forum to facilitate dialogue between member producing and consuming countries from OPEC and IEA, the IEF now has more member countries that those two organisations combined and from all regions of the world.

Notably, the IEF has several large non-aligned countries including China, Russia, India, South Africa and Argentina.

The IEF is led by a Secretary General elected by the IEF Executive Board for a four-year term. The IEF maintains a permanent Secretariat of international staff and is headquartered in the Diplomatic Quarter of Riyadh, Saudi Arabia.

## <u>IEF Secondments Program – Connect, Contribute, Grow</u>

Staff on loan are professionals assigned and loaned by public or private organisations to work at the IEF Secretariat in Riyadh, Saudi Arabia. The duration of the secondment is for a fixed term from 1 to 2 years. During the term, the staff on loan professional remains employed by their current employer but is fully integrated as an IEF staff member, participating in official meetings, mission travel and interacting with member government and industry officials from around the world. The secondments program is particularly beneficial as leadership training for executives or key personnel within companies or organizations providing valuable experience with international affairs and energy sector issues.

The IEF financial package include 1) housing contribution; 2) travel allowance in line with IEF practices; 3) applicable travel visa expenses; 4) monthly subsistence contribution to cover, transport and other living expenses; and 5) other reasonable expenses arising from secondment. A Memorandum of Agreement (MOA) is signed between the IEF, Employer (sending institution) and the individual professional. The MOA outlines the details and conditions of the assignment as well as the activities in which the individual will be involved.
